This position is based at the Fort Meade site of the VA Black Hills Health Care System, and is

organizationally aligned under the Mental Health Service. The mid-level provider (Physician Assistant or Nurse Practitioner) provides medication management services to veterans accessing Mental Health services via Community-Based Outpatient Clinics (CBOCs), primarily the CBOCs located at Eagle Butte and McLaughlin, SD. Work is accomplished remotely, via telehealth.

WORK SCHEDULE: Full-time, 40 hours per week.

#### QUALIFICATIONS REQUIRED:
