The incumbent's primary duties are those of a full journeyman grade electrician. These duties consist of maintaining, repairing, installing, upgrading and troubleshooting all electrical lines, switches, transformers, motors, emergency generators, elevators, refrigeration, air conditioning, controls, and electrical equipment on the station. Performs preventive maintenance on the previously mentioned equipment.

QUALIFICATIONS REQUIRED:

Your background must demonstrate experience in a variety of duties performed by a journeyman electrician such as installing wiring, conduit, fixtures, transformers, and other electrical devices; installing, modifying, maintaining, repairing, troubleshooting, loading, and testing new and existing electrical lines, circuits, systems, fixtures, controls, and equipment; maintenance on elevators, nursecall systems, fire alarm systems, centralized radio systems, electrical warning and detection systems, and other equipment.

PHYSICAL EFFORT: Makes repairs and installations from ladders, scaffolding, and platforms and where the parts of the systems worked on are in hard-to-reach places. This requires them to stand, stoop, bend kneels, climb, and work in tiring and uncomfortable positions. Frequently lifts, carries, and sets up tools, equipment, and parts that weigh up to 20 pounds. Occasionally, may lift and carry items that weigh over 20 pounds.

WORKING CONDITIONS: Work is done inside and outside, and is usually dirty, and greasy. Sometimes required to make repairs and installations outside in bad weather and in work areas that are noisy. Occasionally exposed to the possibility of broken bones, electrical shock, and burns. Frequently exposed to the possibility of cuts and bruises.

EXPERIENCE: A specific length of training and experience is not required, but you must show evidence of training or experience of sufficient scope and quality of your ability to do the journeyman level work of this position. Evidence which demonstrates you possess the knowledge, skills, and ability to perform the duties of this position must be supported by detailed descriptions of such on your resume or OF-612. Applicants will be rated in accordance with the OPM Qualification Standard Handbook X-118C (www.opm.gov/qualifications/x-118c).

SCREEN-OUT ELEMENT: Your qualifications will first be evaluated against the prescribed screen out element, which usually appears as question 1 in the on-line questionnaire. Those applicants who appear to possess at least the minimal acceptable qualification requirement are considered for further rating; those who do not are rated ineligible and are eliminated. The potential eligibles are then rated against the remainder of the questions. The screen-out element for this position is ability to do the work of the position without more than normal supervision.
